The proposed Willington C Gas Pipeline NSIP. Application Reference No: EN060001

I am writing to notify the Examining Authority (ExA) of the applicant's recent change of name. Please note that with effect from the 1st July 2014, RWE Npower plc name was changed to **RWE Generation UK plc**. Please note that the company number and registered address remain the same as there are no changes to the company's legal entity. I attach a copy of the new details obtained from Companies House for your records (as a Certificate of Incorporation from Companies House is not yet available).

In light of this, the applicant, now RWE Generation UK plc, suggests the following update to the ExA's draft development consent order:

- Explanatory Note (page 73) – If the ExA is minded to keep reference to the applicant's name (as opposed to referring to “the undertaker”), this note will also need updating to refer to RWE Generation UK plc.
