Adequacy of consultation request

As previously stated in our correspondence of 4 January 2021, we received the above application for an Order granting development consent on 4 January 2021. A decision whether or not to accept the application for Examination must be made by **1 February 2021**.

A decision must be made whether or not to accept the application for Examination within the period of 28 days, beginning with the day after the date of receipt of the application.

If by 1 February 2021 a decision is made to accept the application for Examination, the Applicant is required to publicise this along with a closing date for anyone to register as an Interested Party and make representations. You will then be able to put your case about the application in writing. You will also be invited to submit a separate Local Impact Report (LIR). A deadline for submitting the LIR will be set once representations have been received and a Preliminary Meeting, which is held to consider how the application would be examined, has taken place.
