RE: CONSULTATION - EDF/HINKLEY POINT C.

We write in the face of further EDF intimidation to add to our submission dated 15th & 20th July.

Contrary to EDF Chief Executive, Vincent de Rivaz' assertions that "EDF is committed to an open and transparent consultation process", (Para.4 of our letter dated 15th July refers), the true extent of EDF's intentions were NOT REVEALED in the stagel consultation and have only come to light because of the vigilance of the Parish Council Campaign Working Group. In short, EDF have misled and are continuing to mislead local residents. Their consultation had been and remains flawed and inadequate and this EDF trickery needs to be remedied.

We refer to EDF's proposals to refurbish Combwich Wharf and intensively use this facility, together with a proposed adjacent lorry park and freight terminal around the clock and to reinforce our objection 2):-

- 7) We strongly object to the anticipated noise pollution, airborne pollution, ie. diesel fumes and dust etc. and night-time light pollution in a rural setting like Combwich.
- 8) Were EDF granted consent in that same setting, we consider that there would be an increased risk of terrorist attack and that the safety of local residents would be compromised to an unacceptable degree and this needs to be taken into account. As we have said, there is a VIABLE ALTERNATIVE.
- 9) We object to the prospect of roads in this locality being permanently gridlocked and to being prevented from having unhindered road access to and from our own home.

Turning again to the inevitable EDF intimidation, this has progressed since our telephone conversation on 8th. September. I can confirm that the police contacted me on 6th. September about the EDF letter and the ILLEGAL EDF recording of their telephone call on 30th. July. We see this as a sinister attempt by EDF to silence us by way of a police prosecution of the writer, using the anti-terror laws. Moreover, after speaking to our telephone provider we believe — as do the company concerned — that the police are tapping our telephone! We are not subversives, we are merely engaged in a totally lawful and democratic right, which I predicted, in our initial telephone conversation would lead to the current situation. With the above in mind, I shall, in due course, write with details as to why we and many other villagers believe EDF has a hidden agenda insofar as Combwich Wharf and Combwichitself is concerned. Copies of self-explanatory letters to Chris Huhne and Vincent de Rivaz are attached.

Dear Mr. Huhne.

I write direct and further to my telephone conversation with Emma on 18th. August in the knowledge that this breaches convention, however, I would stress that I have no complaints against our Constituency MP, Ian Liddell-Grainger.

During the Hinkley C Inquiry of twenty years ago, I ran an effective Media Campaign and the village had the pro-active support of Paddy Ashdown.

In brief, I complain of EDF's activities in this part of Somerset and in particular the village of Combwich where I live. It is a widely held view here that the EDF consultation process is, in short, a notification of an imposition of a nuclear power station and infrastructure with no right of protest. EDF are behaving like fascists and we see landgrab and site clearance at minimum cost being EDF's priority, while villagers' concerns are being ignored. Residents are alarmed and dismayed and this has created a climate of fear. There is now widespread stress in the community and I have heard reports that this has led to some residents suffering mental illness. For example, I am informed that one elderly couple, who do not want to be identified, have been harassed and threatened by EDF because they refused to agree to an EDF purchase of their home.

Moreover, BLACK PROPAGANDA abounds, for instance, it is being spread abroad that the Chinese have bought out the EDF company, together with their astronomical debts! This said, it is beyond my comprehension as to why a foreign (or any) company with a reported £34 billion debt is seen as all powerful and allowed to bully the powerless unhindered.

From my perspective, my household has been under siege for 15 years because I have dared to highlight and criticize the shortcomings of the nuclear industry in this locality. My own and my wife's experiences are outlined in the attached submission to the IPC. To illustrate what I have said, I am enclosing, as an additional item, a copy of a menacing letter - a 'frightener'-from EDF marked A which is intended to deter Mr.& Mrs. Randall from raising any further concerns regarding EDF's activities.

This is England and not Stalin's Russia or North Korea, accordingly, I hope and trust that you will act swiftly and decisively to bring an immediate end to EDF's unacceptable conduct.

For the record, I am a retired, respectable gentleman aged 70 years.
