Horizon Nuclear Power Wylfa Limited: Wylfa Newydd New Nuclear Power Station

Notification in accordance with section 46 of the Planning Act 2008

1. I write on behalf of Horizon Nuclear Power Wylfa Limited ("**Horizon**") regarding its proposals for the construction, operation and maintenance of a new nuclear power station and other development, at Wylfa, Anglesey ("**Wylfa Newydd Project**").
2. Horizon intends to apply to the Secretary of State ("**SoS**") for a development consent order ("**DCO**") for the Wylfa Newydd Project under section 37 of the Planning Act 2008 ("**Planning Act**"). The application for DCO is anticipated to be submitted in the second quarter of 2017. This letter constitutes formal notification of the SoS pursuant to section 46 of the Planning Act.
3. Horizon is now commencing formal pre-application consultation about the Wylfa Newydd Project with the consultation bodies identified under section 42(1) of the Planning Act and this will run until **25 October 2016**. This consultation is Horizon's Stage Two pre-application consultation.
4.
