






1 Introduction

1.1 Explanation of Development Consent Order application errata

- 1.1.1 This document is to present any errata that have been identified within the Development Consent Order (DCO) application for the Wylfa Newydd DCO Project.
- 1.1.2 Errata are errors within the DCO application documents, which are minor in nature and do not change the meaning of documents, analysis or any assessment. These items are presented in Table 2-1 below, and a correction is provided for clarification.
- 1.1.3 Errata items have not been included for documents that have been updated during the examination process. For example, documents such as the Wylfa Newydd Code of Construction Practice (REP2-029) and the Mitigation Route Map (REP2-038). This is because any errors of this nature will have been amended through the process of re-submission.
- 1.1.4 Any errata that have been identified with the Environmental Statement of the DCO application are being presented within the Environmental Statement Addendum (WN0902-HZDCO-PAC-REP-00243) as an appendix and are therefore not shown within this document.
