Dear Mr Thomas,

Application by RWE Npower Renewables Ltd for a Development Consent Order for the Brechfa Forest West Wind Farm project in Brechfa Forest in Carmarthenshire, South West Wales

On 30 November 2011 this application was accepted by the IPC as adequate to proceed for examination. This means that you and your constituents now have the opportunity to make a representation directly to us on the proposal.

The IPC is keen to assist those who are interested in the Brechfa Forest West Wind Farm proposal to understand the application process and in particular to explain the process of registering as an interested party and make a representation. This is a formal step in the application process and we understand the need to ensure that as far as possible, and with the resources available to us, local communities and others are able to be involved in an informed way.

For this reason we are holding drop-in style events with presentation opportunities at Carmarthen Library (12:30 to 16:30) and Brechfa Church Hall (16:30 to 20:00) on 16 December 2011 and 6 January 2012. The purpose of these non-statutory events is to meet with local people in an informal atmosphere to explain the process and provide advice about registering as an interested party to make a representation about the application.

The events are advertised on our website, in the local press and posters have been distributed within the local areas. I have attached a copy of the poster (English & Welsh version) for your information. Please feel free to forward this to anyone you think might be interested in attending and/or displaying copies in additional locations. Please let me know if you'd like us to send you any paper or laminated copies of the posters.

To make a representation about the application people must register with us as an interested party. The registration period opened on 7 December 2011 and it will close on 18 January 2012. Please feel free to distribute this to anyone who may wish to register as an interested party for this application.

I hope the enclosed information will be useful to you, in responding to any enquiries from your constituents about the proposal and / or the role of the IPC.
