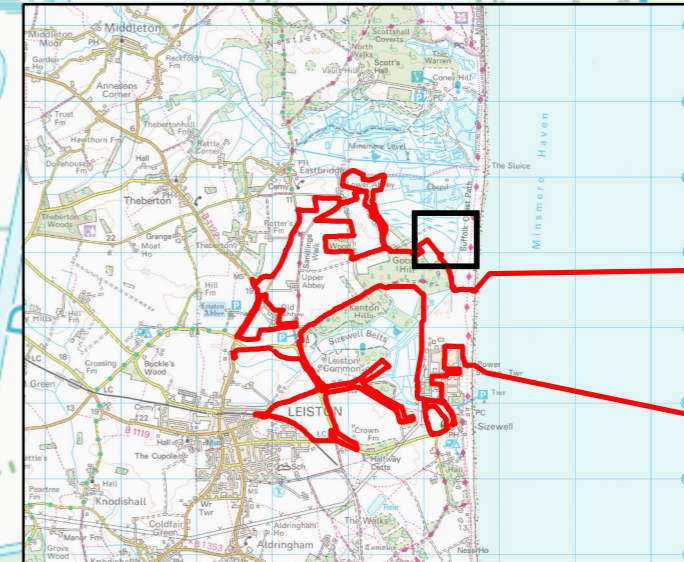
DRAWING TITLE:

 IN RETSOM'S FIELD (OS MAPPING)

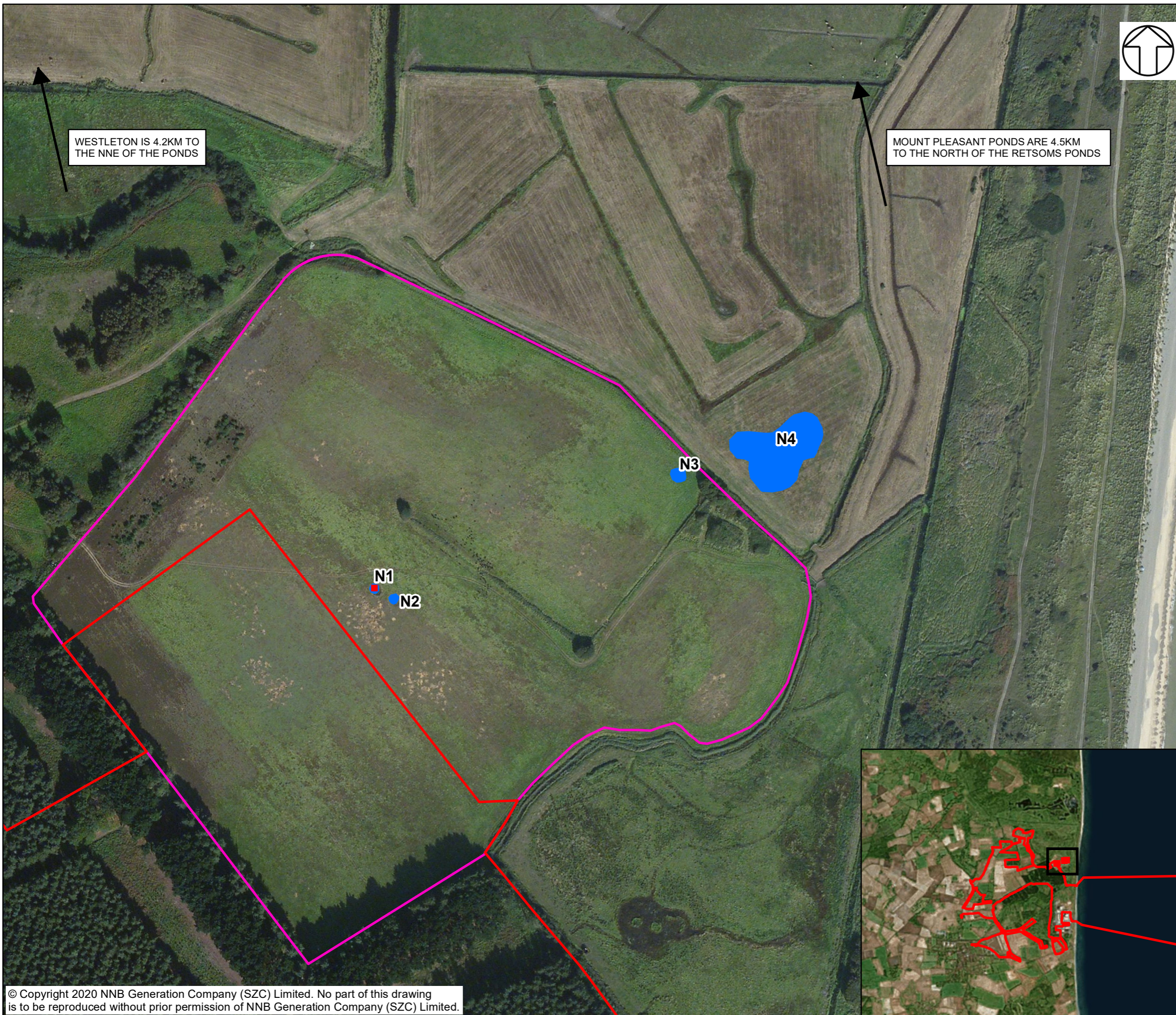

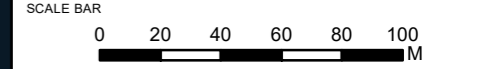

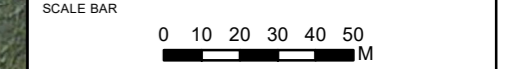
