Dear Sir/Madam,

Thank you for your message from NATS Safeguarding in response to the proposed Sizewell C Nuclear Power Station development, stating that: 'NATS (En Route) Public Limited Company ("NERL") has no safeguarding objection to the proposal'.

However, responses to the current planning application (known as the Development Consent Order application) need to be directed to the Planning Inspectorate.

The planning application for a Development Consent Order (DCO) to build Sizewell C was accepted for examination by Planning Inspectorate (PINS) on 24 June.

We are currently in the Section 56 (s56) Notification Stage (or the formal pre-examination stage) of the planning process, until the deadline of 30 September 2020.
