

Application by NNB Generation Company (SZC) Limited for an Order Granting Development Consent for the Sizewell C Project (Ref: EN010012)

Examining Authority's Record of Unaccompanied Inspection of Sites to which the Application Relates (USI2)

Examining Inspectors Helen Cassini and Edwin Maund (appointed as members of the Examining Authority (ExA) for the application) undertook a second Unaccompanied Site Inspection (USI2) on 16, 17 and 18 February 2021. The purpose of the Inspections was for the ExA to look at specific locations in relation to general surrounds, noise, visual and heritage considerations.

The Inspections were undertaken by car and on foot on public roads and footpaths, so advance permission to enter land was not required. This therefore allowed the Inspections to be undertaken on an unaccompanied basis.

USI2 is recorded in this note, the purposes of which are to inform the Applicant and Interested Parties (IPs) of actions already taken by the ExA and to enable the Applicant and IPs to consider which, if any, additional sites the ExA might need to inspect.

Further Site Inspections may be required. The Site Inspection programmes will be discussed at the Preliminary Meeting (PM) to be held in due course. The Applicant, IPs and other persons will be provided with an opportunity to provide comments to the ExA on the approach that they should take to Site Inspections and to nominate Site Inspection locations. Subject to such public health restrictions as may be in force to respond to the COVID-19 pandemic, opportunities may be provided to propose Inspections of private land, land where accompaniment is required for safety and related reasons and land where specific features need to be drawn to the ExA's attention on an accompanied basis – known as Accompanied Site Inspections (ASIs). If ASIs are not feasible at the relevant time, then alternative processes may be proposed. Before agreeing to Site Inspections at any location, the ExA will consider the degree to which it is necessary to visit a site that has been nominated for an Inspection to inform them about the application. They may decide not to visit nominated locations where they consider that it is not necessary to see the features to be observed there. They may decide not to hold an ASI if all relevant features can be observed and understood from locations in the public domain. More than one Inspection of certain locations may be carried out, to make observation at different times of day and seasons of the year.

Arrangements for any ASIs or alternative virtual processes will be included in the ExA's Examination Timetable and Procedural Decisions. Further USIs may be carried out by the ExA as required to inform them and without notice. However, if further USIs are carried out, further Inspection notes will be published.



Particulars of the Inspection

Day 1: 16 February 2021

The Inspection commenced at 08.00 and concluded at 16.45. Weather conditions consisted of cloud and light breeze. Rain showers occurred late morning and into early afternoon.

The Inspectors undertook separate USI's on Day 3. Weather conditions were bright with moderate wind during the morning, with cloud and rain showers in the afternoon.

Edwin Maund USI

The USI commenced at 08:00 and finished at 15:45, with the following locations being visited:

Sizewell

- Walked from Sizewell past Pillbox field using the Public Right of Way to Rosery Cottages then west north west past the substation/national grid site along Sandy Lane and onwards to the Valley Road/Sandy Lane junction. Continued past properties served off this lane including The Studio
- Travelled along the B1122 through Theberton and north on B1125 to Westleton to appreciate the current environment and context

Yoxford

 Took B1122 onto the High Street (A1120) and through Yoxford as far as Strickland Manor Hill, then round the church off High Street

Saxmundham

 Visited Albion Street, Alma Close, New Cut to observe passenger trains going through Saxmundham and the level crossings in operation to hear both the sirens and the train and to understand the relationship between the properties on the nearby streets to the rail line



Melton

 Visited Melton Railway Station and riverside walk then west to residential and commercial areas adjacent the railway line, to better understand concerns expressed through Relevant Representations in context of rail, traffic and the operation of the level crossing

Woodbridge

 To view residential areas near the railway line to appreciate concerns expressed through Relevant Representations
