Dear Sir or Madam

Having considered the Agenda for the Preliminary Meeting Part 2 and asked for clarification as per the helpful email from the Planning Inspectorate below I would like to make the following points:

- There appears to be no Agenda Item 3
- It appears that not all documents referred to will be available until after Procedural Deadline B of the 7th April

On that basis whilst not wishing to repeat points others may make, I wish to register to speak to ensure the Parish of Kelsale-cum-Carlton is not disadvantaged.

I would like to draw your attention to the fact that 2 consecutive days of looking at screens was very tiring, and hope that it will be possible to have physical meetings. In the interim however the ExA should give due consideration to scheduling breaks at the start of the day, and keeping to them.

Moving onto the examination itself, the sheer volume of late and incomplete documents makes the task of assessing impacts and the potential harm on local communities etc. very time consuming and pressurised for Councillors and other unpaid individuals trying to do their best for their communities. This is afterall a "highly, unusually large and complex application....with very substantial physical works required on a number of sites.." especially bearing in mind it is not the only application for the area.

Whereas for many applications 6 months would be viewed as fair and reasonable, in the circumstances described by Mr Phillpot QC and in the light of the current pandemic together with other proposed infrastructure I would ask that the Planning Inspectorate consider the 'vast scale of the development that is proposed' and reconsider the timetable/timescale.

At the preliminary meeting I believe reference was also made to PD009, could you clarify where I may find that too please?

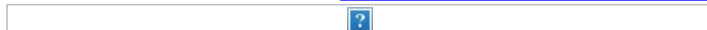
