1. Welcome and Introduction

Wendy McKay (WM) welcomed those present and introduced herself as the lead member of the Examining Authority (ExA) appointed by the Secretary of State (SoS) to examine the application by NNB Generation Company (SZC) Limited ('the Applicant') for the Sizewell C Project.

Edwin Maund (EM), David Brock (DB), Neil Humphrey (NH) and Helen Cassini (HC) introduced themselves as members of the Panel forming the ExA to examine the application.

WM explained the appointment was made by delegation from the Secretary of State on 24 June 2020.

WM explained that the ExA would be examining the application before making a recommendation to the Secretary of State for Business, Energy and Industrial Strategy (BEIS) who will decide whether an Order granting Development Consent for the proposed project, which is a Nationally Significant Infrastructure Project (NSIP), should be made.

WM explained the purpose of the Preliminary Meeting (PM) and noted that the Examination will commence after the PM closes.

The ExA confirmed that all documents and submissions received and accepted during the Examination will be published on the project-specific page of the

National Infrastructure Planning website.

5. The ExA's remarks about the virtual Preliminary Meeting

The ExA outlined the reasons for holding this event virtually and its arrangements

in response to the COVID-19 pandemic.

The ExA noted comments received that have raised concerns about the holding of this meeting, and later events virtually.

6. Initial Assessment of Principal Issues

The ExA explained the purpose of the Initial Assessment of Principal Issues (section 88 of the PA2008), which can be found in <u>Annex C</u> of the <u>Rule 6</u> letter of 23 February 2021 and asked for any observations on them.

The ExA sought comments on the Initial Assessment of Principal Issues from Interested Parties in attendance.

The issues raised have been summarised and are not an exhaustive list:

- Coastal geomorphology.
- Community impacts.
- Area of Outstanding Natural Beauty (AONB).
- Transport Traffic impacts, congestion, overnight rail movements, increased local transport.
- Landscape impact and visual effects.
- Recreational displacement.
- Borrow pits.
- Flood risk modelling.
- Water Framework Directive (WFD) impacts of the Site of Special Scientific Interest (SSSI) crossing.
- Cooling water system.
- Southern Park and Ride site and Northern Park and Ride site.
- Air quality, noise and vibration.
- Two village bypass.
- Hard and soft coastal defences, temporary and permanent Beach Landing Facilities.
- Operational issues and decommissioning issues.
- Mitigation and compensation discussions.
- Impact on the fishing industry, and recreational use of the beach and the sea.
- Changing political environment.
- Hydrogen production.
- Community Safety.
- Health and wellbeing.
- Carbon emissions.
- County wildlife site.
- Peat extraction and transportation.
- Terrestrial and marine ecology.
- Adequacy of electricity transmission lines and implications for the stability of the National Grid.
- Emergency planning.
- Yoxford roundabout.
- Acoustic Fish Deterrent systems (AFD).
- Global Warming.
- Childhood years impacts.
- Tourism.
- Coastal erosion.
- Sizewell Link Road.

These were duly noted and considered by the ExA.

7. The Applicant's proposed changes to the application

The ExA briefly outlined the Applicant's proposed changes to the application.

The ExA welcomed comments from parties in attendance

The issues raised have been summarised and are not an exhaustive list:

- If the changes are accepted, then what is examined thereafter should be the application as changed.
- Content, that the changes would not make the proposal a fundamentally different project.
- Modelling work still to come for the coastal defences and the Beach Landing Facility.
- Decision to accept should be made sooner rather than later.
- Land take implications.
- Funding of the project.
- Heritage implications.
- Lack of engagement.
- Fair opportunity to have views heard and properly considered.
- In the interest of fairness, a need to re consult and add new Interested Parties.
- Greater impacts on the marine environment and greater restrictions on the recreational enjoyment of the heritage coast.
- Concerns surrounding the sea defences.
- Signposting document for the Environmental Statement.
- Concerns how the project can be examined in a six month timescale
- Should be examined in person not virtually.
- Delay to the Examination to allow for proper consideration of the changes along with the need for additional information currently missing from the application.
- Deliverability.
- Concerns about the additional rail movements overnight and the impact on passenger trains.
- Material change not non-material.

All comments received were duly noted and considered by the ExA.

8. Examination Timetable, Hearings and Site Inspections

The ExA welcomed suggestions from the parties in attendance to amend the draft Examination Timetable contained in Annex D of Rule 6 letter.

The ExA clarified the purpose of:

The issues raised have been summarised and are not an exhaustive list:

 Representations were received regarding the date for the submission of Statement of Common Grounds and Written Representations

- Time of election sensitivity to be considered.
- Delay the start of the Examination until the summer or until after COVID-19 lockdown ends.
- Date for Deadline 2 to be pushed back.
- Post hearing submissions to follow all hearings, timetable doesn't currently reflect this.
- Short period of time between change request decision and first submission of Statements of Common Ground.
- Request for the Sizewell link road and the two village bypass to be subject specific hearings for the transport strategy and coastal processes.
- Request for Wickham Market, traffic impacts on Wickham Market and the surrounding parishes.
- Consider other meeting platforms such as Zoom.
- Face to Face hearings not virtual.
- Issue Specific Hearing on net zero.
- Site visit to the Hinkley C Site.
- Site visit from Southwold to Orford.

All comments received were duly noted and considered by the ExA.

- Push back date for submission of Statement of Common Grounds.
- Coastal geomorphology hearings to be held later into the Examination.

All comments received were duly noted and considered by the ExA.

The ExA confirmed a decision would be made no later than 21 April 2021 and a letter would be issued.
