As requested in the Examining Authority's Rule 8 letter, Suffolk County Council ('the Council') has submitted separate documents according to the different 'drop down' submission items.

With this letter, the Council wishes to summarise all its submissions made under Deadline 1, and comment on other items.

### **1. Summaries of all Relevant Representations exceeding 1,500 words**

The Council has submitted a summary of [[RR-1174](#)].

### **2. Comments on Applicant's draft itinerary for ASI and suggested locations for site inspections**

The Council has submitted proposals for additions to the draft itinerary for the ASI, and additional locations with regard to highway concerns to be viewed on unaccompanied site inspections.

### **3. Notification of wish to attend ASI**

The Council has submitted a request to attend the Sizewell C ASI on 8-10 June 2021, noting that it wishes to attend at some locations with more than one officer. The Council also wishes to attend the Hinkley Point C ASI on 22 June 2021.

### **4. Local Impact Reports (LIR) from Local Authorities**

The Council has submitted a joint LIR with East Suffolk Council, supported by a substantial number of Annexes and Appendices. A short abstract/executive summary of the LIR has been submitted alongside the LIR, in accordance with the

Examining Authority's request to accompany any submissions that exceed 1500 words with a summary.

**5. Notification by Statutory Parties of their wish to be considered as an IP by the ExA**

The Council is already registered as an IP.

**6. Notification of wish to speak at any Open Floor Hearing (OFH)**

The Council has submitted, on the appropriate form, a request for Cllr Richard Rout on behalf of the Leader of Suffolk County Council to speak at the OFH. The Council requests that Cllr Hicks be permitted to speak at the first OFH session on Tuesday 18 May in the morning. It would be helpful if there could be consecutive speaking slots of Cllr Rout and the Deputy Leader of East Suffolk Council, Cllr Craig Rivett.

**7. Notification of wish to make oral representations at an Issue Specific Hearing (ISH)**

The Council has submitted a request to make oral representations at all Issue Specific Hearings and anticipates wishing to speak on most topics.

**8. Notification from any Affected Person of wish to speak at a Compulsory Acquisition Hearing (CAH)**


