Dear Planning Inspectorate.

On behalf of Aldeburgh Town Council IP# 20026721 we would request that you visit the following locations.

(We understand you stood in the beach car park and looked North but it was not clear if you also walked in the area)....we would request that you revisit the beach car park and then walk North to Thorpeness and continue along the beach footpath all the way to Sizewell and onto Minsmere and Dunwich - to experience the fragility of the cliff and importance of the coastline as a place of inspiration to artists, and tranquillity/mental and physical health healing for the public and its role within the tourism industry.

We would also request that you walk from Aldeburgh caravan park along the old Railway line to Thorpeness.

From the Moot Hall south along the seafront to the Martello Tower and all the way to the gate to Orfordness Island (again to see the fragility of the existing sea defences and shingle ridge).

From the Aldeburgh Sailing Club car park along the river wall west turning up Dump Road to the Allotments, through the Allotments to Kings Field recreation field, past the Community Centre and Fire station to the roundabout, then west along Saxmundham Road and down to the River at the Brickdock. Retracing your steps and back down the Saxmundham Road until you reach the car park and turn left to take the Sailors Path through to Snape Maltings Concert Hall.

To drive from Aldeburgh to Leiston looking to the east at the distant view of the existing power stations and note the gap to the left of the Sizewell B dome.

To continue through Leiston and out beyond Theberton to the junction at Yoxford (noting the narrowness of the road and volume of traffic) joining the A12 heading North to Southwold and to see the view looking south from Southwold on the beach to Sizewell, noting the gap to the right of the SZB dome. We would suggest that this journey is repeated leaving Aldeburgh at 7am and again at 4:30-5pm to experience potential cumulative impact with Sizewell B shift change.

We would also request that you spend some evenings/overnight on the beach and surrounding areas.

We hope you will also walk (or cycle) along the Suffolk Coastal Path and the Sandlings Walk, along the Road to and from, and on site at RSPB Minsmere, walking through to all the hides and the beach.

Walk from the Eels Foot Pub car park in Eastbridge - back along the road and turn and walk down the public footpath (adjacent to the Old Post Office) out to the sea, passing the old

abbey - which is a popular walk for our residents and visitors.

We also think it would be a very good idea to enable Parish/Town Council representatives to visit Hinkley Point C power station either at the same time as the Planning Inspectorate or subsequently to enable us to participate in the Examination of the DCO especially regarding the dDCO and to understand what evidence we need to present to you from lessons learnt by colleague councils adjacent to the Hinkley Point C site.
