Dear Ms Richards,

I am extremely concerned to learn that EDF Energy has today submitted a Development Consent Order (DCO) application in respect of their proposed nuclear power station, 'Sizewell C' in Suffolk.

Although I welcome the communication which I received this morning from EDF Energy's Managing Director for Nuclear Development, Mr Humphrey Cadoux-Hudson, I continue to have significant concerns about the impact that the ongoing COVID-19 restrictions will have upon the ability of local communities to engage in the relevant processes.

I have been contacted by a great many constituents who have raised their ongoing concerns regarding this application. It is my opinion that opportunities for genuine public consultation on the DCO will be greatly curtailed as public meetings are not currently permitted. Due to the significant local and national impacts of an application of this scale, it is vital that sufficient time and resource is made available to properly and fully consider the Sizewell C DCO application.

It is also important to consider that many organisations, including the Planning Inspectorate and County and District councils, are most likely currently operating with reduced staffing and remote working practices in place. As the DCO application must be considered within 28 days, in which time County and District councils are mandated to respond to questions about EDF's community consultation, the reduced capacity of all organisations due to COVID-19 raises significant concern. It is imperative that local councils are not distracted from delivering essential frontline services during the battle against COVID-19.

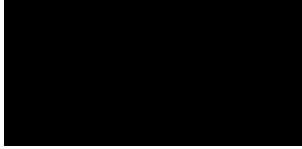
