I have been reviewing the representations made in respect of this development and it is apparent that the overwhelming majority are against the application

Taking the first 160 or so , of the 10 pro development responses, I have established that there are multiple responses from the same interested party - namely Melin Wynt Cambwll Cyf which has responded in its own name and also there are responses from John Ellis Pritchard (Director) and Sheila Pritchard (Wife of Mr Ellis Pritchard and Director of EcoUtility Energy Ltd the planning applicant for the Melin Wynt turbine) together with Louise Pritchard (family member);. The representation from Melin Wynt indicated that the company has received support from the proposed developer (RWE Npower) which has been beneficial to its business.

In addition I have established that there is at least one representation from an Apprentice employed by RWE (Natasha Frost)

While it is legitimate for any interested party to submit representations, how is the Inspector proposing to differentiate between those that are made by parties who have financial ties to the developer and others?
