Visions for a brighter future

Positive plans ahead for our major town centres

Exciting plans for our town centres have been unveiled.

Mid Sussex District Council will meet today to discuss its masterplan for Haywards Heath, setting out a range of options to improve the town including a multi-storey carpark, more leisure facilities, making South Road more attractive to shoppers, pedestrianising The Broadway and altering the Muster Green gyratory.

Meanwhile in Burgess Hill, an initiative to promote new

sustainable businesses has been launched, bringing an empty unit back into use at The Martlets, Town council Robert Eggleston negotiated favourable leases from NewRiver, which is behind the town centre's development plan. He said: "We have no control over the redevelopment and cannot say when, or if, it will happen. But what we can do is bridge the gap and give opportunities to local entrepreneurs and support the local economy through incredibly difficult circumstances.
