Vattenfall Wind Power Ltd – proposed Kentish Flats Offshore Wind Farm Extension Formal Request for Advice under s.51 of the Planning Act 2008

We are writing to you in relation to the above application for the Kentish Flats Extension ("the Application"), which was submitted to the IPC on 14 October 2011.

In the event that the IPC accepts the Application for examination, Vattenfall wishes to move forward with the post-application steps as quickly as possible. As part of this, Vattenfall will be required to give notice of the Application in accordance with section 56(2) of the Planning Act 2008 ("the Act").

Under section 56(2)(a) Vattenfall must notify those persons prescribed, being those relevant from the list provided Schedule 1 of The Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 ("the Regulations"). As part of the environmental statement scoping process, Vattenfall were provided by the IPC with a list of the relevant prescribed persons and this formed the basis of the consultation carried out under section 42 of the Act. A copy of that list is enclosed.

We are, however, aware that a number of the organisations who were consulted under s.42 either no longer exist or their functions have been transferred. We set out in the table below those consultees we have identified as falling into these categories:

We understand that the IPC is aware of this issue and is itself considering the effects of the changes proposed on the list of prescribed consultees in Schedule 1 of the Regulations. However, in the absence of any formal guidance we should be grateful for advice under section 51 of the Act on the following points:

- (a) Confirmation that the Relevant Police Authority (Kent Police Authority) should be notified under section 56(2) of the Act if the Application is accepted;
- (b) Information as to any replacement bodies for those identified in the table above who must be notified; and
- (c) Details of any further deletions or replacements identified by the IPC from the enclosed list provided to Vattenfall.

We look forward to receiving the IPC's advice on these matters as soon as possible and if any further information or clarification is required please do not hesitate to contact us.
