**Application by Vattenfall Wind Power Ltd for a Development Consent Order for the Kentish Flats Extension project, off the north Kent coast to the north of Whitstable and Herne Bay**

On 10 November 2011 this application was accepted by the IPC as adequate to proceed for examination. This means that your constituents now have the opportunity to make a representation directly to us on the proposal.

In order to do this, people must first register with us as an interested party. The developer started the registration period on 28 November 2011 and it will end on 6 January 2012. Please feel free to distribute this to anyone who may wish to register as an interested party for this application.

Registering as an interested party will enable people to take part in the IPC examination, make their representation in writing and take part in any public hearings at the discretion of the Examining Authority.
