The North Killingholme (Generating Station) Order 2014

Notice under Section 127(7)

1. The North Killingholme (Generating Station) Order 2014 which has been submitted by C.Gen Killingholme Limited to the Secretary of State includes the land and new rights described in the schedule.
2. The land was acquired by the statutory undertaker (Centrica Storage Limited) for the purpose of their undertaking and the Secretary of State is satisfied that an interest is held in the land for the purposes of the carrying out of Centrica Storage Limited's undertaking.
3. Notice is hereby given that the Secretary of State in exercise of his powers under section 127 of the Planning Act 2008 has certified that the land and new rights described in the schedule can be purchased and not replaced without serious detriment to the carrying on of Centrica Storage Limited's undertaking.
4. Notice of authorisation of compulsory acquisition of the land will be made by the prospective purchaser (C.Gen Killingholme Limited) in accordance with section 134 of the Planning Act 2008.
