Dear Mr Williams,

I write on behalf of the Applicant, Capture Power Limited, and attach the following documents in respect of Deadline 1:

1. Document Ref. 3.1, Rev. 3 - Application Index: This has been updated to reference the documents that are being submitted for Deadline 1.
2. Document Ref. 3.4, Rev. 1 - Schedule of Statutory Undertakers: This has been provided in response to procedural decision 6. at Annex C of the Examining Authority's (ExA's) Rule 8 letter dated 29 April 2015. It is intended to be a 'live' document that will be updated during the course of the Examination.
3. Document Ref. 6.4.5, Rev. 07 - ES Volume 3, Section L - Habitats Regulations Assessment Report: This has been provided in response to procedural decision 4. at Annex C of the ExA's Rule 8 letter. The updated Habitats Regulations Assessment report includes the requested cross-referencing in the foot notes to the screening and integrity matrices.
4. Document Ref. 6.5, Rev.1 - Environmental Statement Mitigation Annex: This has been provided in response to procedural decision 5. at Annex C of the ExA's Rule 8 letter. The document brings together all the mitigation needs and measures for the Project and identifies how these will be secured. Again, this is intended to be a live document that will be updated during the course of the Examination.
5. Document Ref. 8.1, Rev. 2 - Draft Statement of Common Ground (SoCG) with North Yorkshire County Council and Selby District Council: This is a draft SoCG that is still subject to agreement with the authorities. A first draft was discussed at a meeting with the authorities on 8 May 2015. The authorities provided written comments on the first draft today. The Applicant will update the draft SoCG to take account of those written comments and further dialogue with the authorities and will provide a further draft at Deadline 2.
6. Document Refs. 8.2 to 8.6, all Rev. 1 - Draft SoCG with the Canal & River Trust, Natural England, Historic England, the Yorkshire Wildlife Trust and the Environment Agency: These drafts are subject to agreement with each of the listed bodies. The Applicant will endeavour to provide further drafts at Deadline 2.
7. **Document Ref. 9.1, Rev. 1 - Applicant's Response to the ExA's First Written Questions, including appendices. Please note that the appendix to ExA Question 6.8 (Q6.8 – Appendix 1) relates to further badger survey work and should be treated on a confidential basis and not uploaded to the PINS website. Please note this document and the appendices will follow on separate emails.**

8. Document Ref. 9.2, Rev. 1 - Applicant's Comments on Relevant Representations
