Dogger Bank Teesside A Offshore Wind Farm Project – Non-material change application to the **Development Consent Order**

Following on from our previous correspondence providing an update on the Dogger Bank Teesside A project and the proposed non-material change application, we can now confirm that the application has been submitted to the Secretary of State for Business, Energy and Industrial Strategy (BEIS), alongside a parallel application to the Marine Management Organisation to amend the relevant Deemed Marine Licences.

As previously noted, the Project is seeking an amendment to the Development Consent Order to enable the most efficient and cost-effective project to be built. An overview of the proposed changes is provided in Table 1 along with details of some of the related parameters that will remain unchanged.
