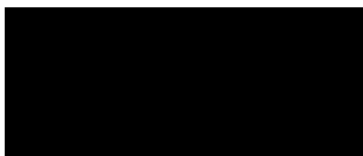
**Non-Material Change Application to the Dogger Bank Teesside A and B Offshore Wind Farm Order 2015 (as amended) – Dogger Bank Teesside A and Sofia Offshore Wind Farm**

On 13 May 2020 the Marine Management Organisation (MMO) received notice that Sofia Offshore Wind Farm Limited and Doggerbank Offshore Wind Farm Project 3 Projco Limited have submitted a joint non-material change application to The Department for Business, Energy and Industrial Strategy (BEIS) to make changes to the Dogger Bank Teesside A and B Offshore Wind Farm Order 2015 (as amended). This letter comprises the MMO's response in respect of this non-material change application.

The non-material changes being sought are to allow for the separation of the two projects (Project A and Sofia) which are being taken forward by separate project companies, and to enable flexibility for the discharge and enforcement of the relevant requirements on a project specific basis as the projects proceed.

The MMO has no objection to the amendments proposed in the non-material change application.
