The Dogger Bank Teesside A and B Offshore Wind Farm Order 2015 (“the Order”) - Variation to the Teesside A (“Dogger Bank C”) Deemed Marine Licences

In August 2015 the Secretary of State for Energy and Climate Change granted consent for the Dogger Bank Teesside A and B Offshore Wind Farm Order 2015 (“the Order”) which included, in Schedules 8, 9, 10 and 11, four Deemed Marine Licences (DMLs) in accordance with Section 149 of the Planning Act 2008. Following the granting of the 2015 Order, in August 2017, the project was split. Dogger Bank Teesside A (“Dogger Bank C”) is now owned by Doggerbank Offshore Wind Farm Project 3 Projco Limited (“the Projco”); and Dogger Bank Teesside B (“Sofia”) is owned by Sofia Offshore Wind Farm Limited.

On 20 December 2019, the Marine Management Organisation (MMO) received a request from Doggerbank Offshore Wind Farm Project 3 Projco Limited to vary the Teesside A DMLs (Schedules 8 and 10) contained within the Order. The request was to increase the permitted rotor diameter for individual wind turbine generators, amend the stated gross electrical output capacity, include titanium as an optional material, alter the procedure for dropped objects from the provision of an audit sheet to the provision of a dropped object form, amend ornithology monitoring conditions, change certain conditions to allow for a phased discharge, and amend the emergency response and cooperation plan (ERCoP) conditions.

The MMO has now completed its consideration of these requests and, in exercise of the powers conferred by section 72(3) (d) of the Marine and Coastal Access Act 2009, has varied the DMLs as detailed in the Notices of Variation enclosed.

Also enclosed is a copy of the varied DMLs.

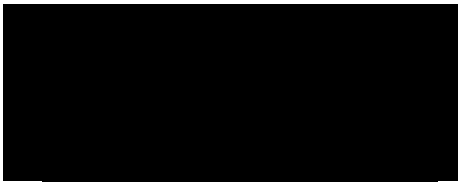
