On 20 December 2019, the Marine Management Organisation (MMO) received a request from Doggerbank Offshore Wind Farm Project 3 Projco Limited to vary the Deemed Marine Licences (DMLs) for Dogger Bank Teesside A, contained within Schedules 8 and 10 of the Dogger Bank Teesside A and B Offshore Wind Farm Order 2015.

Following consultation with relevant stakeholders the MMO has now completed its consideration of the request and, in exercise of the powers conferred by section 72(3)(d) of the Marine and Coastal Access Act 2009, has determined to make the variations as detailed in the attached documents.
