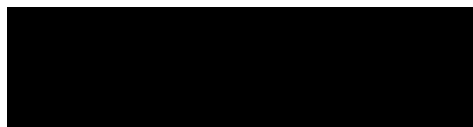
**Hornsea Two Offshore Wind Farm Order – Application Reference: EN010053 (“the Project”) -
Withdrawal of Representations by E.ON E&P UK Limited (E.ON) (company number 02761032)
and Bayerngas Europe Limited (Bayerngas) (company number 05735294)**

We refer to the application for the above Development Consent Order for the Project.

E.ON have submitted a number of representations to the examination of the Project on their behalf, and on behalf of their development partner Bayerngas, in relation to the potential effect of the Project on E.ON and Bayerngas’ current and future plans for the development of their assets and strategic interests in the vicinity of the Project’s proposed development area.

E.ON, Bayerngas and the applicant for the Project (Optimus Wind Limited and Breesea Limited, together the “Applicant”) have been in discussions about the interface between the Project, and E.ON and Bayerngas’ interests and infrastructure. These discussions have resulted in the conclusion of a private commercial agreement between the parties to provide for the protection of E.ON and Bayerngas’ interests and infrastructure. On this basis, E.ON and Bayerngas are satisfied that their concerns expressed within their representations have been adequately addressed and, by consequence, wish to withdraw their representations in relation to the Project with immediate effect. E.ON and Bayerngas also hereby confirm that there is no requirement for any protective provision to be included for their protection in the Development Consent Order for the Project.
