An application has been made to the Secretary of State under paragraph 2 of Schedule 6 to the Planning Act 2008 (a) and in accordance with the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011 (b) for a non-material change to The Hornsea Two Offshore Wind Farm Order 2016 (c);

The Secretary of State, having considered the application and the responses to the publicity and consultation carried out under regulations 6 and 7 of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011 (d), has determined to make an Order giving effect to the proposed change, which in the opinion of the Secretary of State is not material.

Accordingly, the Secretary of State, in exercise of the powers in paragraph 2(1) and (9) of Schedule 6 to the Planning Act 2008 (e), makes the following Order:

Citation and commencement

1. This Order may be cited as The Hornsea Two Offshore Wind Farm (Amendment) (No. 2) Order 201[X] and comes into force on [] 201X.

Amendment to the Hornsea Two Offshore Wind Farm Order 2016

- 2.—(1) The Hornsea Two Offshore Wind Farm Order 2016 is amended as follows.
- (2) In Paragraph 3(1) of Part 1 (Authorised Development) of Schedule 1 (Authorised Project) for "up to 6 offshore HVAC collector substations" where it occurs substitute "up to 3 offshore HVAC collector substations".
- (3) In Paragraph 3(2) of Part 1 (Authorised Development) of Schedule 1 (Authorised Project) for "must not exceed 6" substitute "must not exceed 3".

EXPLANATORY NOTE

This Order amends The Hornsea Two Offshore Wind Farm Order 2016, a development consent order under the Planning Act 2008, following an application made in accordance with the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011 for non-material changes under paragraph 2 of Schedule 6 to the Planning Act 2008. The Order amends the permitted number and permitted parameters of the authorised offshore HVAC collector substations.
