Dear Mr Smith,

I email as a representative of St. Paul's VA Primary School, following my attendance at the Planning Inspectorate hearing which took place on 28th and 29th October 2016, at Redwither Tower, Wrexham.

The site proposed for the Gas Power Station is less than 1000 metres from our school site.

The Industrial Estate in Wrexham has grown significantly in recent years, and as a result our school now suffers from: factory and vehicle noise, smells and odours, also heavy traffic using the B5130 (now a strategic route serving the estate). These impact heavily on the education of our children; as we are unable to open windows in the hot summer months or walk our children to the local church or village hall.

Our school caters for children aged 3 to 11 years. We currently have 8 children who use asthma inhalers. Can it be guaranteed that the emissions from the Power Station will not negatively affect the health and well being of children in my care? Have the health impact assessments undertaken specifically considered the effects of any emissions on children?

Lastly, I believe that should the Power Station go ahead, prospective parents will be deterred from choosing our school.
