East Anglia THREE and East Anglia FOUR Offshore Windfarms

East Anglia THREE Ltd and East Anglia FOUR Ltd, subsidiaries of East Anglia Offshore Wind Limited (EAOW) have each published Statements of Community Consultation in accordance with Section 47 of the Planning Act 2008.

The Statements of Community Consultation aim to provide local communities within the vicinity of the projects with an outline of the consultation process we are proposing to undertake. Separate documents have been produced for each project.

Each offshore wind project covers an area of approximately 370 km² and is located around 70 km from the East Anglia Coast.

We currently intend to submit separate applications for consent to the Planning Inspectorate for each project between November 2014 and spring 2015.

We are interested in hearing your views on the projects, and invite you to give your opinions by 31st October 2013.

All correspondence received throughout the development of each project will be recorded and considered and will be included in a formal consultation report, to be submitted alongside the applications for consent.

To launch the consultation programme for the projects, we will be holding information days, where members of the project team, together with specialist consultants, will be available to answer any questions you may have at this early stage. No appointment is necessary and we welcome you to attend.
