Dear M. Hunt,

As my colleague David Catot told you last week, the French local authorities wish to participate to the consultation on the East Anglia Three Offshore Windfarm. Regarding the likely impacts of this project, the Region Nord-Pas-de-Calais-Picardie considers it appropriate to hold a public consultation on its territory. In application of article 4 of the Espoo Convention, the French local authorities will contact you to fix the modalities of this participation (to this end, M. CLAVREUIL Pierre is in copy of this email).

At this stage, the Maritim Prefecture of Manche and Mer du Nord also has a few comments to make on this project and the information transmitted :

- the impact assessment on the activities of foreign commercial fishing fleets, particularly the fleets of neighboring countries such as France, is described as "tolerable", without further details. It would be pertinent to examine precisely what the real impact on the French fleet that usually frequent the site.
- The assessment of the impacts also demonstrated probability of interference, during the operational phase, with the civil and military radars.

As part of the development of future French wind farms, it would be interesting that France could be kept informed of future consultations of this project, to be aware of studies and evaluations of which will serve him to analyze the possible reduction measures impacts for its own parks
