Thanks for the call yesterday, it was helpful to understand your concerns in a bit more detail.

As discussed, due to the nature of the approach to laying of onshore cables for East Anglia THREE i.e. pulling cables through pre-installed ducting (put in place by East Anglia ONE) rather than intrusive open trenching works, and as confirmed by our detailed traffic assessment, impacts to road users are considered to be low. Indeed you advised that your own internal assessment also concluded that impacts will be low risk to Royal Mail operations.

I would envisage the main source of roadwork's for EA THREE would be the construction of accesses and temporary highway improvements along the cable route.

There are two mechanisms whereby East Anglia Three Ltd would apply for Temporary Roadworks if required:

- 1) Serve notice to the Local Highway Authority under the New Roads and Street works Act 1991 (NRSWA)
  - 2) Apply for a temporary restriction (road closure, speed limit restriction) under the Road Traffic Regulation Act 1984
- 
- 1) Requires the statutory undertaker to give advanced notice of roadworks and publish key information (start, duration, type of work) in a national streetworks gazetteer. I believe that Royal Mail, as a registered utility, will have access to this information.
  - 2) If the roadworks require closures or speed restrictions then an order must be obtained following publication of a notice in local press and a circular letter which is sent to various organisations such as District/Parish Councils, the Police and other emergency services and bus companies. This function is typically carried out by the LHA and we would ensure that Royal Mail is included in the list of consultees, although in all likelihood this may already be the case.

There is also the issue of abnormal indivisible loads (ails) to consider.

There is a requirement to seek permission from the LHA as well as the emergency services and give advanced notice. I understand there is no requirement to consult further, however, the LHA will use their powers to ensure that the movements cause minimum disruption, typically specifying off-peak and night-time movements. In addition, the Outline Traffic Management Plan submitted with the East Anglia THREE application for Development Consent (November 2015) includes a commitment to local liaison groups to avoid roadworks conflicts with planned events – I consider it would be good practice to add Royal Mail to any such circulars.

Hopefully this addresses your concerns and provides you with the level of comfort required that Royal Mail will be appropriately consulted and therefore made aware of any key traffic matters on the East

Anglia THREE project.
