Dear Sacha,

Progress Power Limited (PPL) has submitted an application for a “non-material change” application to the Secretary of State for Business, Energy and Industrial Strategy, which seeks to address the uncertainties and constraints posed by the COVID-19 pandemic, in relation to its ability to formally commence construction works by August 2020, in accordance with the [Progress Power \(Gas Fired Power Station\) Order](#) (‘the Order’). The application seeks to extend the time limit for commencing

construction by up to 12 months. No other changes are proposed to the Order.

Before a decision can be made by the Secretary of State, PPL must consult with a variety of persons in accordance with the requirements of the Infrastructure Planning (Change to, and Revocation of, Development Consent Order) Regulations 2011 ('the 2011 Regulations'). Your organisation has been identified as a consultee.
