THE PROGRESS POWER (GAS FIRED POWER STATION) ORDER – NON-MATERIAL CHANGE APPLICATION

Thank you for your letter of 29 May 2020 regarding the above application relating to a non-material change on the following Development Consent Order: The Progress Power (Gas Fired Power Station) Order 2015 (SI 2015/1570) as corrected by the Progress Power (Gas Fired Power Station) (Correction) Order 2016 (SI 2016/736) And as amended by The Progress Power (Gas Fired Power Station) (Amendment) Order 2016 (SI 2016/1086).

The proposed non-material change is to extend the time limit for commencing construction by 1 year so that the deadline for commencing construction will be 13 August 2021.

On the basis of the information available to date, we do not wish to offer any comments on this application for non-material change. We suggest that you seek the views of specialist conservation and archaeological advisers at West Suffolk Council and Suffolk County Council, as relevant.
