CONSULTATION AND PUBLICITY STATEMENT UNDER REGULATION 7A OF THE INFRASTRUCTURE PLANNING (CHANGES TO, AND REVOCATION OF, DEVELOPMENT CONSENT ORDERS) REGULATIONS 2011 ("THE 2011 REGULATIONS")

THE PROGRESS POWER (GAS FIRED POWER STATION) ORDER 2015 (SI 2015/1570) AS CORRECTED BY THE PROGRESS POWER (GAS FIRED POWER STATION) (CORRECTION) ORDER 2016 (SI 2016/736) AND AS AMENDED BY THE PROGRESS POWER (GAS FIRED POWER STATION) (AMENDMENT) ORDER 2016 (SI 2016/1086) ("THE ORDER")

- 1. Progress Power Limited (PPL) of Drax Power Station, Drax, Selby, YO8 8PH applied to the Secretary of State for Business, Energy and Industrial Strategy for consent to make a non-material change to the Order under Section 153 of the Planning Act 2008, on 29th May 2020.
- 2. This document constitutes PPL's consultation and publicity statement pursuant to Regulation 7A of the 2011 Regulations.
- 3. A copy of the notice published under Regulation 6 of the 2011 Regulations (the "Notice") is enclosed at Appendix A.
- 4. PPL confirms that:
 - 4.1. As required under Regulation 6(1) of the 2011 Regulations, it has published the Notice in the East Anglian Daily Times (a local newspaper circulating in the vicinity in which the land is situated) on the following dates:
 - 29th May 2020; and
 - 5th June 2020.
 - 4.2. Copies of extracts from the East Anglian Daily Times are enclosed at Appendix B.
- 5. Although there is no statutory requirement for an Applicant to post and maintain a Notice at the Project Site for a non-material change application under the 2011 Regulations, due to the restrictions imposed by the Health Protection (Coronavirus Restrictions) (England) Regulations 2020 (as amended), PPL posted and maintained 9 notices at the Project Site and surrounding area. The notices were erected on 29th May 2020 and checked on 4th June 2020. Details of the locations of the notices are provided at Appendix C.
- 6. PPL has sent the Notice to all those persons required to be consulted under Regulation 7(2) of the 2011 Regulations. Those persons consulted are listed in Table 1 of Appendix D. The Notice was sent to each of the consultees on 27 or 28 May 2020 (for those who received the Notice by post) and on 29 May 2020 (for those who received the Notice by email). The majority of notices were delivered to consultees on or before 29 May 2020.
- 7. A small number of notices were not delivered when they were originally sent. In all cases, this was as a result of returned deliveries or difficulty in obtaining proof of delivery from Royal Mail. Following diligent inquiries, PPL re-sent those notices and confirmed delivery of them, as explained in Table 2 of Appendix D.
- 8. The deadline specified in the Notice for representations to be submitted to the Planning Inspectorate was 10 July 2020. All consultees had 28 days or more from receipt of the Notice to the 10 July 2020 to submit representations.



- 9. The application documents have been made available to view on the Planning Inspectorate's website (<u>https://infrastructure.planninginspectorate.gov.uk/projects/eastern/progress-powerstation/?ipcsection=overview</u>) and the Progress Power project website (<u>https://www.drax.com/about-us/our-projects/progress-power/</u>). The Notice invited recipients unable to access either website to request hard copies of the documents free of charge.
- 10. Due to the restrictions imposed by the Health Protection (Coronavirus Restrictions) (England) Regulations 2020 (as amended), PPL has not been able to place a copy of the application documents at Eye Library for public inspection for the representation period. PPL has been informed by Eye Library that whilst the library will re-open on 7 July 2020, there will be limited service/access within the building and no browsing will be allowed meaning users would not be able to view the application even if PPL provided a copy of the documents. PPL considers that the steps it has taken to make its application available for inspection accord with the written ministerial statement made by the Minister for Housing on 25 June 2020 in respect of the move to online inspection of documents and the practical measures required to ensure fair participation.
- 11. Additionally, PPL has engaged in other pre-application communications prior to submitting the nonmaterial change application. This included:
 - Discussion with Mid Suffolk District Council regarding the forthcoming non-material change application and PPL's publication and consultation proposals;
 - Discussion with Suffolk County Council regarding the forthcoming non-material change application;
 - Advance communications to the Environment Agency and Natural England; and
 - Advance communications to locally elected members.
- 12. A copy of the covering letter sent to locally elected members as part of the pre-application communications is enclosed at Appendix F.







We write further to the above. You may be aware of the Progress Power development, which is planned at the above industrial estate, and its associated gas and electrical connections, the latter being made at a new substation north of Yaxley.

As an energy generating project with output over 50 megawatts, the development was authorised under the Planning Act 2008 via a "Development Consent Order", granted in 2015. This was subsequently amended by further Orders granted in 2016.

Progress Power Limited (PPL) will be shortly submitting a "non-material change" application to the Planning Inspectorate which seeks to address the uncertainties and constraints posed by the COVID-19 pandemic, in relation to its ability to formally commence construction works by August 2020, in accordance with the Order.
