

PROPOSED NON-MATERIAL CHANGE APPLICATION ("NMC2 Application") REGULATION 7(3) – REQUEST FOR APPROVAL OF THE CONSULTEE LIST

Dear Mr Paterson,

## **BACKGROUND**

- 1. As you know, we act for Enfinium Limited ("**Enfinium**") in relation to the present proposed non-material change to the 2015 Order. The original 2015 Order was previously corrected and amended on two occasions as follows:
  - 1.1 The Ferrybridge Multifuel 2 Power Station (Correction) Order 2016; and
  - 1.2 The Ferrybridge Multifuel 2 Power Station (Amendment) Order 2018 ("2018 NMC1 Order").
- 2. The 2018 NMC1 Order effected a non-material change to the 2015 Order in relation to the re-provision of landscaping and biodiversity enhancement which the 2015 Order had required be undertaken in a designated approved area. Since the 2015 Order was first made, a need was identified to utilise the approved area for the development of an independently operated ash processing facility and the approved area was therefore no longer able to be used to provide the landscaping and biodiversity enhancement.
- 3. The 2018 NMC1 Order replaced the original approved area with an alternate and improved area of landscaping and biodiversity enhancement on land located approximately 300 metres to the north-west of the original approved area. This replacement land was already owned by a joint venture partner of the (then) applicant, and delivery of the enhancements was secured by way of an accompanying development consent obligation made under section 106 of the Town and Country Planning Act 1990.

- 4. The 2018 NMC1 Order also effected the substitution of a revised biodiversity strategy, landscape strategy and landscaping plan to reflect the amended location of the landscaping and biodiversity enhancement on the replacement land.
- 5. It can be seen, therefore, that the 2018 NMC1 Order was of a much different order of change compared the scope of the change now proposed to be included in the NMC2 Application.
