The Applicant would also like to update the ExA on the discussions that have taken place with Network Rail since the hearings in May 2018. The Applicant met with Network Rail on 7 June 2018 to discuss the Project, in particular the proposed Access Road and construction traffic management proposals in respect of the Green Lane Level Crossing. The Applicant is proposing to address some of Network Rail's concerns by amending the draft DCO and Outline Construction Environmental Management Plan to be submitted for Deadline 5. Discussions are ongoing between the parties in respect of the extent of any protective provisions to be included in the draft DCO and the Applicant will provide a further, more detailed, update for Deadline 5.
