Millbrook Power Limited: Proposed gas fired power plant at Rookery South Pit, Nr. Millbrook, Bedfordshire

In accordance with the programme set by the Examining Authority (ExA) in the Rule 8 letter published on 20 March 2018, Millbrook Power Limited (the "Applicant") encloses for Deadline 5:

- I. Applicant's revised draft DCO (clean word and pdf versions);
- II. Applicant's revised draft DCO (comparison with version 2);
- III. Revised Explanatory Memorandum (clean);
- IV. Revised Explanatory Memorandum (comparison with version 2);
- V. Updated Guide to the DCO Application Documents (Annex 1 of this letter), which was submitted as part of the DCO Application (Document Reference 1.1: introduction to the Applicant and Guide to the Application Guide to the DCO Application Documents [APP-001] and updated at Deadline 2 [REP2-001], Deadline 3 [REP-008] and Deadline 4 [REP4-001];
- VI. Revised Land Plans;
- VII. Revised Works Plans;
- VIII. Revised Rights of Way, Streets and Access Plans;
- IX. Revised Site Location Plan;
- X. Revised Existing Site Layout Plans;
- XI. Revised Indicative Site Layout Plans;
- XII. Revised Book of Reference (clean);
- XIII. Revised Book of Reference (comparison with version 1);
- XIV. Revised Statement of Reasons (clean) (The Statement of Reasons includes an update on negotiations with landowners.);
- XV. Revised Statement of Reasons (comparison with submission version);
- XVI. Schedule of Amendments to the DCO, Explanatory Memorandum, Book of Reference and Statement of Reasons;
- XVII. Draft S106 Agreement (The draft S106 Agreement has been agreed with CBC, BBC, the Forest of Marston Vale and the landowner (O&H). Engrossments are being prepared for signature); and
- XVIII. Revised CEMP (Version 2).

Non Material Amendment

As explained in paragraph 5.2.4 of the Statement of Reasons (submission version) [APP-014] and paragraph 60.2 of the Explanatory Memorandum (submission version) [APP-013], the intention has always been for the access road for the Project to connect to any road that may be constructed by the undertaker (Covanta Rookery South Limited) pursuant to numbered work 5A of the Rookery South (Resource Recovery Facility) Order 2011. The Applicant has always made it clear in the



Application and in the Examination, that it would not be seeking to construct an access road from Green Lane if such an access road had already been constructed by Covanta. In such a scenario, the Applicant would only construct the Short Access Road to connect the Generating Equipment Site to the end of that existing access road. This was referred to as Option 2A and 2B in all of the Application documents.

This issue was also discussed at the compulsory acquisition Hearing on 3 May (see paragraphs 3.22-3.23 of the written summary of the Applicant's oral case on compulsory acquisition [REP3-012] and referred to in the Applicant's response to first written question 1.12.2 [REP2-016] and second written question 2.1.1 [REP4-002].

The Applicant has made it clear throughout the Examination that it would amend the Order limits and reduce the extent of plot 4_PGP in the event that the access road was constructed by Covanta pursuant to numbered work 5A of the Rookery South (Resource Recovery Facility) Order 2011.

The access road has now been completed (with the exception of the creation of a new junction with Green Lane) and the Applicant is now acting on its intention as set out in the Application documents, at the Examination Hearings and in responses to the Examining Authority's written questions. Accordingly, the Applicant requests that the Examining Authority accepts the proposed non-material amendments to the Order limits and plots 4_PGP and 5_PGP and the related amendments to the extent of numbered work 2A in Schedule 1 of the DCO.

The Applicant has had regard to the Planning Inspectorate's Advice Note 16 '*How to request a change that may be material*'. Paragraph 2.1 of the Advice Note states that there is no legal definition of what is material, but the tests to apply are whether the change is substantial, or whether the development now being proposed is not in substance that which was originally applied for.

The Applicant submits that the changes proposed are not substantial and the development now being proposed is substantially the same as that which was originally applied for. As stated above, the Application documents made it clear that the access road may be constructed pursuant to numbered work 5A of the Rookery South (Resource Recovery Facility) Order 2011. Furthermore, this has been clearly stated orally and in writing during the Examination process.

No additional land or works are being proposed. Instead, the Order limits and Order land are being **reduced** and part of the authorised development removed as it is no longer required. There will be no new or different likely significant environmental effects as the Environmental Statement [APP-033] assessed both the construction of the Access Road (Option 2A) and the construction of just the Short Access Road (Option 2B).

The Applicant has sent the proposed changes to the landowner (O&H), Covanta and Network Rail for comment. The Applicant considers that the proposed changes address some of the concerns raised by Covanta and the Examining Authority in respect of the overlap between the Project and the RRF Facility:

- O&H has confirmed that it agrees to the changes.
- Covanta's Solicitor has confirmed that the proposed changes to the draft DCO (Revision 3) are agreed. Covanta is currently reviewing the changes to the land plans and works plans but has been unable to confirm approval or otherwise for this Deadline.
- Network Rail is currently reviewing the changes but has been unable to confirm its approval or otherwise for this Deadline.

Covanta and Network Rail are participating in the Examination and will have the opportunity to comment on the proposed changes at Deadline 6. The Applicant will inform the Examining Authority if it receives confirmation that the changes are agreed by either Covanta or Network Rail prior to Deadline 6.

The Applicant has considered whether, without re-consultation on the requested change(s), any of those entitled to be consulted or who were consulted on the original application (including persons



who are not an Interested Party in the Examination) would be deprived of the opportunity to make any representations on the changed application. Given the nature of the proposed changes, and the fact that both Option 2A and Option 2B were consulted on as part of the s42 consultation and s56 relevant representation period, and the fact that this issue has been the subject of oral Hearings and written questions with the Applicant's intention to reduce the order limits and order land should Covanta build the access road from Green Lane, the Applicant considers that there are no persons who would be affected by the proposed changes who would be deprived of the opportunity to make representations on the changes.

The proposed works to create a junction with Green Lane remains the same as that proposed in the Application. The relevant planning authorities, Central Bedfordshire Council and Bedfordshire Borough Council, were present at the Hearings are therefore aware of the proposed changes. The relevant planning authorities will have the opportunity to comment on the proposed changes at Deadline 6.
