

#### NOTICE OF APPLICATION TO MAKE A NON MATERIAL CHANGE TO THE FOLLOWING DEVELOPMENT CONSENT ORDER:

#### THE MILLBROOK GENERATING STATION ORDER 2019 (S.I No. 578)

Notice is hereby given that an application has been made by Millbrook Power Limited ("MPL") of Drax Power Station, Drax. Selby, United Kinadom, YO8 8PH to the Secretary of State for Business, Energy and Industrial Strategy (BEIS) to make a nonmaterial change to the Millbrook generating station order 2019 (S.I. No. 578).

 The Order grants development consent for the construction,

operation and maintenance of generating equipment including one Gas Turbine Generator with one exhaust gas flue stack and Balance of Plant (together referred to as the 'Generating Equipment'), which are located within the 'Generating Equipment Site'; works to an existing access road and construction of a new access road from Green Lane to the Generating Equipment Site (the 'Access Road' and the 'Short Access Road'); a temporary construction compound required during construction only (the 'Lavdown Area'):

- a new underground gas pipeline connection, to bring natural gas to the Generating Equipment from the National Transmission System (the 'Gas Connection').
- · a new electrical connection to export power from the Generating Equipment to the National Grid Electricity

Transmission System ("NETS") (the 'Electrical Connection').

The Application seeks to make non material amendments to the Order to enable the relocation of the substation within the order limits to a location previously occupied by the Sealing End Compounds (SECS) following a change in substation design and technology. The temporary transfer tower which forms part of work package 6 is no longer

required and downleads are proposed from the existing pylon to the proposed location of the substation.

In addition to the non-material changes required for the new substation solution, MPL is also seeking to amend the extent of the baseline works which are referred to in Requirement 20 of Schedule 2 to the Order, MPL considers these changes to also be non-material.
