Thank you for the confirmation. 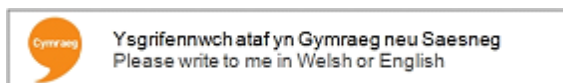

I will be attending the preliminary meeting with colleagues on behalf of the Local Authority. We have no special requirements and may wish to speak on items 3, 4, 5, 6 and 7.

In this regard, the Local Authority wishes to seek an extension of time for the submission of the Local Impact Report, Statement of Common Ground and potentially the Written Representation until **Friday 9<sup>th</sup> November 2018**. I have just returned from paternity leave today to the Rule 6 letter. The Council Constitution provides delegated authority to the Planning Committee to submit Local Impact Reports, Written Representation and agree a Statement of Common Ground on Nationally Significant Infrastructure Projects within the City & County of Swansea (No. A.45 of the table in Section 1.8 of the Council Constitution -
