Notice of the decision by the Secretary of State

I write to notify you of the publication of the Secretary of State's decision and statement of reasons and the Order granting development consent in relation to the above application.

The Secretary of State as the decision maker under s103 and s104 of the Planning Act 2008 (as amended) (PA2008) has decided that development consent should be granted and therefore has made an Order under s114(1)(a) of PA2008.

There is no right of appeal under PA2008. The High Court may entertain proceedings to question an Order granting development consent from the day on which the Development Consent Order is published or, if later, the day on which the decision letter is published. The procedure is to make an application for judicial review. This must be done within the statutory period of time set out in s118 of PA2008.
