**The Glyn Rhonwy Pumped Storage Generating Station
(Amendment No.2) (Wales) Order 2023**

An Application has been made, under paragraph 2 of Schedule 6 to the Planning Act(a) to the Secretary of State in accordance with the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011(b) for non-material changes to the Glyn Rhonwy Pumped Storage Generating Station Order 2017(c).

The Secretary of State, having considered the application, the responses to the publicity and consultation required by regulations 6 and 7 of the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulations 2011, has decided to make the changes proposed in the application.

Accordingly, the Secretary of State, in exercise of the powers conferred by paragraph 2(1) and (9) of Schedule 6 to the Planning Act 2008, makes the following Order—

Citation and commencement

1. This Order may be cited as the Glyn Rhonwy Pumped Storage Generating Station (Amendment No.2) Order 2023 and comes into force on [].

Amendment to the Glyn Rhonwy Pumped Storage Generating Station Order 2017

2. The Glyn Rhonwy Pumped Storage Generating Station Order 2017, as amended by the Glyn Rhonwy Pumped Storage Generating Station (Amendment) (Wales) Order 2021(d), (“the 2017 Order”), is amended in accordance with this Order.

Amendments to Schedule 2 (requirements)

3. For paragraph 2 of Part 2 of Schedule 1 to the 2017 Order substitute “The authorised development must be commenced no later than 29 March 2026.”.
