I refer to my letter of 5 March 2015 (150305_EN010073_3036108). It has come to my attention that the Planning Inspectorate incorrectly identified your organisation as a non-prescribed consultee for the purposes of requesting information in respect of the above proposed development.

Whilst Bristol City Council was correctly identified as a statutory consultee with respect to its role as harbour authority for Bristol City Docks it should also have been identified as a Local Authority for the purposes of section 42(1)b of the Planning Act (2008) (as amended), rather than a Local Authority non-statutory consultee. This is due to the potential for the proposed project to affect land within the adjacent local authority administrative boundary, based on Bristol City Council's boundary with Cardiff City Council at Flat Holm Island. Bristol City Council is therefore a prescribed consultee in accordance with Regulation 9(1)(a) of the EIA Regulations.
