

## Frequently Asked Questions

1. I would like to be involved in both East Anglia ONE North and East Anglia TWO Examinations. Do I have to register for both applications?

**YES. IF YOU WISH TO HAVE YOUR SAY ON BOTH EAST ANGLIA ONE NORTH AND EAST ANGLIA TWO APPLICATIONS, YOU MUST REGISTER FOR EACH APPLICATION SEPARATELY. AFTER REGISTERING FOR EACH APPLICATION, YOU WILL RECEIVE A UNIQUE REFERENCE FOR EACH APPLICATION. YOU SHOULD QUOTE THE RELEVANT REFERENCE WHEN CONTACTING THE PLANNING INSPECTORATE ABOUT EITHER APPLICATION.**

2. Do I need to register for both applications if my views are in relation to only one of the applications?

**NO, YOU CAN CHOOSE TO ONLY REGISTER IN RELATION TO THE ONE APPLICATION IN RELATION TO WHICH YOU WISH TO MAKE A REPRESENTATION**

3. Will I receive correspondence separately for each application?

**YES, IF YOU HAVE REGISTERED FOR EACH APPLICATION, YOU WILL RECEIVE SEPARATE CORRESPONDENCE FOR EACH APPLICATION.**

4. Will I need to submit representations separately for each application, even if I wish to raise the same issues for each application?

**YES, YOU WILL NEED TO SUBMIT REPRESENTATIONS SEPERATELY, AS EACH APPLICATION WILL BE EXAMINED SEPARATELY**

5. Will there be one Case Team for both applications?

**THERE IS A SEPARATE CASE TEAM FOR EACH APPLICATION. THE CONTACT DETAILS ARE AVAILABLE ON THE PROJECT SPECIFIC WEBPAGE**

6. Will there be one Examining Authority for both applications?

**CONSIDERATION IS BEING GIVEN TO THE POSSIBILITY OF APPOINTING THE SAME PERSONS TO THE TWO EXAMINING AUTHORITIES. HOWEVER SHOULD THIS HAPPEN, BECAUSE THE PROJECTS ARE TWO SEPARATE APPLICATIONS THERE WILL STILL BE TWO SEPARATE EXAMINATIONS WITH SEPARATE EXAMINING AUTHORITIES. ONCE THE EXAMINING AUTHORITIES APPOINTMENTS HAVE BEEN MADE, THEY WILL BE PUBLISHED ON THE PROJECT SPECIFIC WEBPAGES.**

7. Will the Examining Authority hold separate or joint hearings during the Examinations?

**IT WILL BE A DECISION FOR THE EXAMINING AUTHORITY FOR EACH APPLICATION ONCE APPOINTED, TO DETERMINE HOW EACH APPLICATION WILL BE EXAMINED.**
