The PM Part 1 was held on Wednesday 16 September. The following detailed Agenda is for the PM Part 2 and builds on that issued with the Rule 6 Letter for each application [hyperlinks]. The Agenda summarises each item to be discussed and includes a list of speakers for each item. This list is based on the comments and attendees to Part 1 and comments raised in the written submissions submitted by Procedural Deadline C.

The allocation of persons to each Agenda item is based on the Examining Authorities' (ExAs') understanding of topics which people wish to raise, and where such topics fit best into the Agenda. The ExAs hope that this proves useful and provides further clarity to attendees, as well as helping to make the PMs run as smoothly and efficiently as possible. The list of speakers does not preclude you making points at other times in the Agenda, should you not be listed overleaf to do so.

For guidance, to avoid virtual event fatigue, session breaks will be provided after approximately 90 minutes of business, subject to ExA discretion to reduce or prolong a session to provide breaks at natural break points in the business. In the first session, 90 minutes will include the Arrangements Conference, so the first break will be taken at approximately 50 minutes after the start of the meeting. A break will also be taken between Items 12 and 13 on the Agenda to enable the ExAs to deliberate on their procedural decision. This may or may not coincide with the session break, depending on the progress of the meeting. As many sessions will be held as are required to cover the matters on the Agenda.
