Please find attached the following.

- 1. A summary of our written representations. We have made written representations on 18 topics relating to the above projects as set out in this summary. The written representation in relation to each topic will be sent by separate email to accommodate the 12 MB file size limit. In some cases due to the size of the attachments for a particular topic more than one email will be sent per topic. Each email will be clearly marked in respect of the topic to which it relates. A list of our written representations is also attached to this letter.
- 2. A document entitled Request for Accompanied Site Inspections nominating locations and justifications for site inspections for consideration by the ExA and notification of our wish to attend Accompanied Site Inspections.
- 3. A document setting out our responses to the ExAs written questions (ExQ1) in respect of those questions directed to us plus a small number of others for which we wish to volunteer a response.

In addition we wish to advise you as follows.

- 1. In relation to post hearing submissions in respect of OFH1 we would wish the transcript of Michael Mahony's contribution at OFH1 to be treated as a written submission.
- 2. We wish to speak at Issue Specific Hearings 1 and 2 and may be represented by both counsel, Mr Richard Turney, and Michael Mahony at those hearings.

- 3. We wish to reserve the right to speak at any further open floor hearings but only to the extent that matters arise during the course of the examination which we consider need to be addressed orally.
- 4. We confirm that we wish to have future correspondence received electronically.
- 5. Although our relevant representations exceeded 1500 words (they comprise 1846 words) we have been advised by the Planning Inspectorate that we do not need to submit a summary.
- 6. In relation to Statements of Common Ground respect of Cultural Heritage, Landscape, Flood Risk and Noise as you are aware we have been focusing our attention to the preparation of our written representations.
