1 Introduction

- 1. Written Representations have been received from Interested Parties (IPs) for the East Anglia ONE North and East Anglia TWO offshore windfarms ('the Projects'). East Anglia ONE North Limited and East Anglia TWO Limited ('The Applicants') have classified each IP as either a stakeholder the Applicants have engaged with as part of the Statement of Common Ground (SoCG) process, members of the public / businesses, or an IP which has been identified as persons with an interest in land.
