#### **Clarification Notes**

We have some comments on a number of the clarification notes submitted by the Applicant and those will follow shortly. In the event they are not submitted by the end of today we would respectfully ask the Examining Authorities to consider exercising their discretion to accept them.

### National Grid's Participation in the Examination Process

As Examining Authorities are aware, National Grid and its divisions have played and will continue to play a pivotal role in the promotion and, if consented, the construction and operation of these projects not least given that:

- i) one of the three NSIPs for which development consent is sought is a National Grid project;
- (ii) National Grid selected the area (which includes Friston) as the site for its NSIP; and
- (iii) the National Grid NSIP will be a new connection hub to which at least six further offshore energy projects will connect, two of which are NGV promoted NSIPs and two of which are NGET/NGESO projects.

Accordingly its direct participation in the examination process is essential both by attending and participating in hearings and in the production of all relevant documents and information to the Examining Authorities.

However we are aware that National Grid through its solicitors has stated that it does not "anticipate" attending hearings. Therefore should National Grid not attend Issue Specific Hearing 2 we would wish to address the Examining Authorities on this subject.
