2.	<p>The Planning Balance</p> <p>Action 1 for OFHs 1 [see Note B] asks participants in that hearing for an explanation of their oral submissions that the proposed developments would result in adverse impacts which would outweigh the benefits of the applications, with reference to the provisions of s104(7) of the Planning Act 2008. Could speakers in this hearing please do the same in writing, making reference where necessary to any justification for an approach in which the offshore works might be recommended for consent but the onshore works might not – a ‘split decision’.</p>	Fiona Gilmore and other speakers referring to this point D5
