## **Comments on Rule 8 Letter**

The Applicant notes the amended Examination timetable in Annex A of the Rule 8 Letter and would request that the ExA's commentary on and/or schedule of changes to the dDCO and the ExA's Further Written Questions (ExQ3) are published earlier than 20 May 2021 if at all possible. This would provide the Applicant and Interested Parties with additional time to review and provide detailed responses in advance of Deadline 11 on 7 June 2021 noting that one week of hearings are provisionally scheduled during the week commencing 24 May. It would also provide those that are participating in the hearings on Tuesday 25 to Thursday 27 May time to consider the ExA's comments on the DCO in advance of the DCO hearing on Friday 28 May 2021 where such parties are also required to prepare for and participate in the other hearings that week.

### Notice of intention to request a change to the Order Limits

The Applicant wishes to provide advance notice that following further engagement with Interested Parties (including the Wardens Trust and Natural England), the Applicant intends to submit a request to amend the Order limits for Work No. 9 at Plot 13 to increase the distance between the onshore cable corridor and receptors to the east.

The Applicant is currently preparing the material to support this change request and is consulting with relevant Interested Parties and Affected Persons (noting that the change does not give rise to any new Interested Parties or Affected Persons). The Applicants propose to submit the request to the ExA on 22 April 2021. This will set out full details of the proposed change, and will be accompanied by supporting documentation.
