




1 Introduction

2 Comments on EDF Energy Nuclear Generation Limited's Deadline 9 Submission

1	This letter contains the Deadline 9 response in respect of both of the above proposals from EDF Energy Nuclear Generation Limited ("NGL"). NGL is the owner and operator of the nearby Sizewell B nuclear power station ("SZB"). Further to our deadline 8 submission dated 25 March 2021, the position remains that the Protective Provisions are agreed subject to the conclusion of a side agreement. A confidential side agreement has been agreed with the Promoters and has been signed by NGL. We understand from the Promoters that the Easter break has limited the availability of signatories at its end. However, we are informed that the Promoters will be arranging signing next week. We hope to be in a position to update the Examining Authority further next week.	The protective provisions contained within Part 7 of the draft DCO have been agreed with EDF Energy Nuclear Generation Limited ("NGL") and the confidential side agreement has now been completed. The Applicants understand that NGL is now in a position to withdraw its representation in respect of the Projects.
