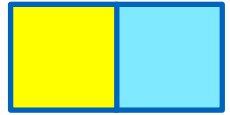
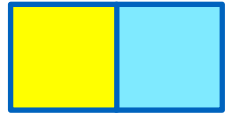

2	2. I refer to the submissions made in respect of ISH 15 Action Point 2 submitted at deadline 8. Whilst the Applicants have amended the Statement of Reasons to correct the reasons for which plots 115 and 116 are required this has not been reflected in Schedule 9 to the DCO where both column 3 and column 4 need to be corrected to conform with the amended Statement of Reasons in accordance with my previous submission.	Please see the Applicants' Comments on Michael Mahony's Deadline 8 Submissions [REP9-023] submitted at Deadline 9. The Applicants updated the Statement of Reasons at Deadline 8 to address Mr Mahony's comments however the Applicants do not consider that any updates are required to the draft DCO as the rights specified in Schedule 9 align with the works required over the relevant plots.
